Your Official Information Act request, reference: GOV-037037

Thank you for your email of 9 December 2024, asking for the following information under the Official Information Act 1982 (the Act):

- For all clients who have an accepted ACL injury claim between Jan 01, 2018 Dec 31, 2023.
 The following data points:
 - a. Patient demographics
 - b. Identifier, date of birth, sex/gender, ethnicity
 - c. urban/rural location of the patient
 - d. Income level (or a proxy, if available)
 - e. Details of the ACL injury
 - f. date of injury
 - g. Associated injuries (i.e. cover for meniscal tear or other ligament tears)
 - h. mechanism of injury,
 - i. what sport played when injured (if injured through sport)
 - j. Utilisation of healthcare services
 - k. If they had ACL reconstruction
 - Length of time from injury to ACL reconstruction (if applicable)/ OR if easier, date of ACL reconstruction,
 - m. number of physiotherapy sessions following their injury
 - n. date of last physiotherapy session (to understand duration of physiotherapy rehab post injury)
 - i. if they utilised ECP/ICP MSK services
 - ii. if they utilised ECP/ICP MSK how long until discharge
 - iii. if they utilised ECP/ICP MSK how many physio sessions attended
 - iv. if they utilised ECP/ICP MSK final outcome
 - v. Employment status
 - vi. light or heavy labour occupation type
 - vii. time taken to return to work -
 - viii. vocational support received)
 - ix. Other
 - x. Home help or childcare support utilised,
 - xi. travel assistance utilised
 - xii. Total cost of claim

As discussed, via email on 11 December 2024, we are unable to provide identifying information, such as dates of birth under the Act. Requests for client-level data for research purposes are reviewed by ACC's Ethics Panel. More information is available at:

ACC is unable to provide information about whether a client lives in an urban or rural location as this information is not recorded. Please find enclosed a breakdown of the data by client location.

Information about clients' income levels have been refused under section 18(f) of the Act, as providing it would require us to conduct searches through individual client accounts, which amounts to substantial collation and research.

In doing so, we considered extending our timeframe to respond and charging (as allowed under the Act). However, it was determined that the resources required to extract the data would unreasonably interfere with the everyday functions of the teams involved.

Notes and caveats:

This report includes claims which include an accepted diagnosis that includes the phrase "anterior cruciate ligament". This includes complete or partial tears, ruptures, strains and sprains, and other unspecified internal derangements.

Only accepted claims are included in this report. We've also excluded declined injuries on claims that are otherwise accepted. Claims which are managed by accredited employers are not included in this report.

All tables include separate figures by client gender. Note that a small number of clients whose gender is another gender or unknown in our records have been excluded from this report. These exclusions make up fewer than four claims.

Claims are included based on their accident date. Data may change in future as additional claims are lodged for accidents that have already happened. Tables that include information about service and entitlement costs may also change as additional invoices are received and paid for services that have already happened.

Other specific notes about individual data are provided below the tables on the following sheets where relevant.

All costs provided are exclusive of GST.

The data was extracted on 19 December 2024 and may differ if rerun at a later date.
