#### **Description:**

The number of claims and reviews for cover for work-related gradual process injuries between 01 January 2019 and 31 October 2024.

#### **Caveats and Notes:**

- Work-related gradual process claims have been identified where the claim is gradual process indicator is set to 'Y' and the claim was funded from the work account or the accident is at work indicator is set to 'Y'.
- Claims managed by an accredited employer have been included.
- Data are displayed in calendar years, i.e. 01 January to 31 December.
- New claims is the count of claims that were lodged with ACC between 01 January 2019 and 31 October 2024. The lodgement date may be any date after the accident occurred.
- The review type for data in tables 2 and 3 is 'Cover'.
- Table 2 is the number of reviews that were lodged in the specified period, while table 3 is the number of reviews that were resolved in the specified period. The review outcome meanings are below.

Dismissed / Withdrawn: A reviewer finds in ACC's favour.
 Quashed: A reviewer finds in the client's favour.

- Overturned: A review specialist overturns the decision in a client's favour and asks them to withdraw the review application.

- Modified: A formal review hearing decision modifies ACC's initial decision.

- Data were extracted on 11 December 2024 and may differ if re-run at a later date.
