

Your Official Information Act request, reference: GOV-030777

Thank you for your email of 27 February 2024, asking for the following information under the Official Information Act 1982 (the Act):

What link shows the comparative cost of treating a similar injury, ie: a Rotator Cuff tear cost - Physiotherapy, verse the cost of an Orthopaedic opinion with conservative Rx, management only, (without surgery) verse the cost of the same or similar injury being seen in a DHB?

What is the cost to ACC of a simple Lumbar Sprain, Physiotherapy - manual therapy, verse Integrated/Enhanced Care Pathway, verse Chiropractic, verse, Osteopath, verse Acupuncturist, verse Musculo Skeletal Medical Practitioner, verse Orthopaedic Surgeon without surgery

Costing different treatments for an injury

A rotator cuff tear injury would likely require both physiotherapy and orthopaedic input making it difficult to provide comparative costs between physiotherapy treatment and conservative management by an orthopaedic surgeon. Orthopaedic surgeons also tend not to manage a client if surgery is not required. In this case, the client is referred either for rehabilitation, or back to the referring provider.

With respect to treating a simple lumbar sprain, a client would be expected to recover within 3-6 weeks. Therefore, these clients are unlikely to see an orthopaedic surgeon or musculoskeletal medical practitioner. They also would not enter the integrated care pathway since a lumbar sprain does not meet the inclusion criteria.

Noting the above points, ACC does not hold information on the comparative costs for different treatment pathways for these injuries. Therefore, we are refusing your request under section 18(g) of the Act. However, to assist you, we are able to provide some high-level cost information on treatment costs for different provider types, and comparative costs of treatment on a per claim basis.

ACC costs by provider type

The cost of orthopedic services are contained within the clinical services contract which is available on our website, here: https://www.acc.co.nz/assets/contracts/clinical-services-schedule.pdf

Most physiotherapy services are funded under Cost of Treatment Regulations, which outline a contribution that ACC pays for injury related consultations and treatment. These regulations can be viewed at the following link:

The average number of treatments by a physiotherapist is four to five.
