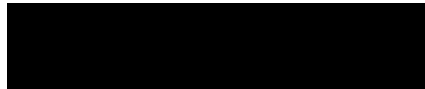

Your Official Information Act request, reference: GOV-031448

Thank you for your email of 31 March 2024, asking for the following information under the Official Information Act 1982 (the Act):

1. *Can you please provide information concerning ACC funded courses as part of an injured persons vocational rehabilitation.*
 - a. *The total dollar amount spent on courses for injured persons in each of the last 5 years.*
 - b. *The percentage of injured persons who gain qualifications from courses that have been ACC funded in each of the last 5 years?*
 - c. *The number of courses by duration; type of qualification; at tertiary level; in each of the last 5 years.*
2. *Does ACC collect data on injured persons digital literacy, access to computers, access to WIFI. If so, how is that data collected and analysed.*
3. *The numbers of injured workers who gain cover under schedule 2 claims?*
4. *The number of injured workers declined cover under schedule 2 claims?*
5. *The types of injuries and exposures approved/declined under schedule 2.*
6. *The number of claims approved /declined for entitlements due to suicide?*

Vocational rehabilitation

Information about courses or qualifications we have funded as part of vocational rehabilitation is contained on individual claim files and it is not recorded in a collatable way. Due to this, we cannot determine information without manually reviewing information held on individual claim files where we have paid for vocational rehabilitation. Due to this, we are refusing this part of your request as the information cannot be made available without substantial collation and research. This decision is made under section 18(f) of the Act. In doing so, we consider that extending our timeframe to respond or charging (as allowed under the Act) would not enable us to avoid a significant impact on our operations.

Digital literacy and access to computers/Wi-Fi

ACC does not collect data on digital literacy or access to computers and Wi-fi.

Schedule 2 claims

The requested information is provided in the attached Excel file. When reviewing the information, please refer to the notes provided.

Some values in table 2 only indicate that the claim count is fewer than four (denoted as <4) to protect our clients' privacy. This decision has been made under section 9(2)(a) of the Act. In doing so, we have considered the public interest in making the information available and have determined that it does not outweigh the need to protect our clients' privacy.

Suicide claims

The requested information is also provided in the attached Excel file.

Please note that Section 119 of the Accident Compensation Act 2001 (the AC Act) outlines when wilfully self-inflicted injuries or suicide may or may not be covered. This can be viewed here: www.legislation.govt.nz/act/public/2001/0049/latest/DLM101487.html.

Claims where the injury was self-inflicted or from a suicide need special consideration. ACC does not decline fatal claims solely because they are as a result of suicide. Rather, wilfully self-inflicted claims are often accepted and then disentitled. Description:

Accepted and declined claims for those assessed under Schedule 2.

Accepted and declined claims due to fatal wilfully self-inflicted injuries.

Caveat and Notes:

- Claims are included where the cover decision is accept or decline. Duplicate claims and claims where the cover decision is not yet made have been excluded.
- Claims managed by an accredited employer are not included.
- Claims identified as assessed under schedule 2 (Tables 1 and 2) have been identified where the claim has a schedule 2 indicator. Please note that this indicator is based on a keyword search and may not represent all claims assessed under Schedule 2.
- Claims identified as fatal wilfully self-inflicted claims are identified where the claim is flagged as fatal and has an active wilfully self-inflicted indicator.
- While ACC does not decline claims because they are wilfully self-inflicted, these claims are usually disentitled. As such ACC data should not be considered a comprehensive count of fatal wilfully self-inflicted injuries as many may not be lodged with ACC in the first place where no entitlements are available.
- New claims are counted where the claim is lodged with ACC between 1 January 2019 and 31 March 2024. A claim may be lodged immediately following an accident or at any later stage.
- Data are displayed in calendar years, i.e. 1 January to 31 December.
- In the interest of client privacy, claim counts of less than four claims have been replaced with '<4'. A&R does not recommend releasing unsuppressed data.
- Data were extracted 18 April 2024 and may differ if re-run later.
