- What level of detail would be possible? Obviously, any identifying information couldn't be provided but do you collect information about the size of the workplace etc?

On 10 May, we advised you that we could not identify the size of the workplace from our data. You confirmed with us that you would still like to receive the requested claims data.

Caveats and Notes:

- All claims included are accepted for cover.
- Claims managed by an accredited employer have been excluded.
- The claim lodgement date is between 01 January 2005 and 14 May 2024.
- Territorial authority is based on the location that the accident took place and may not be where the client was residing at the time.
- All claims included are either in the 'Motor Vehicle' fund or the road indicator on the claim is checked to 'Yes'.
- For tables 1 and 2, claims are identified where the claim fund is in the work account, or the work indicator on the claim is checked to 'Yes'.
- Claims are included where the accident road agency on the claim is equal to one of the following categories. The accident road agency is the vehicle the client was using at the time of the accident.
 - Driving/Passenger Bus
 - Driving/Passenger Car
 - Driving/Passenger Motorcycle
 - Driving/Passenger Truck
 - Driving/Passenger-Other Veh
- New claims is the count of claims that were lodged with ACC in the specified period. The lodgement date may be any date after the accident occurred.
- Data were extracted on 15 May 2024 and may differ if re-run at a later date.
