# Your Official Information Act request, reference: GOV-032422

Thank you for your email of 24 May 2024, asking for the following information for the last five years:

- 1. Number of work-related mental injury assessments undertaken
- 2. Number of these found to have a work-related mental injury.
- 3. Diagnoses for those with a work-related mental injury
- 4. Employers of those with a work-related mental injury.
- 5. Work capacity of those with established work-related mental injuries.
- 6. Age, sex, ethnicity of those with work-related mental injuries
- 7. Costs/work related mental injury.

Due to the nature of your request, we are responding under the Official Information Act 1982 (the Act).

### Please find the requested information attached

This information is provided in the attached Excel file. It includes the following information for work-related mental injuries lodged between 1 January 2019 and 31 December 2023:

- Table 1 accepted vs declined (questions 1 and 2)
- Table 2 costs to date of accepted clams (question 7)
- Table 3 most prevalent diagnoses (question 3)
- Table 4 weekly compensation days paid (indicative information for question 5)

- Table 8 work classification associated with clients with accepted (question 4).

Please note that in the tables provided, we have used the value '<4' if the number of claims is between 1 and 3. We have also suppressed some numbers (denoted as '..') to ensure that small values cannot be calculated from totals. We have taken these measures to ensure that individuals cannot be inadvertently identified from statistical information we release.

This decision is made under section 9(2)(a) of the Act. We consider the need to withhold this information is not outweighed by the public interest in release.

#### **Description:**

Number of work related mental injuries assessment undertaken.

Number of claims for work related mental injuries, broken down by diagnosis, employers, weekly compensation days band, client's age, gender and ethnicity. Number of active claims and costs for work related mental injuries.

#### **Caveats and Notes:**

- Claims managed by an accredited employer are not included.
- Claims are considered to be claims for work related mental injury that has accessed assessment service if:
  - Claim lodgement date is between 01 January 2019 and 31 December 2023 AND
  - Claim with work related mental injury indicator that has payments under service item code 'CPSP1 Clinical Psychiatrist Other Injury Assessment' or claim has payments under service item code PSY52 Psychological Services Assessment for WRMI cover' AND
- Claims are considered accepted where the an injury with one of the following keywords was approved. Those with an injury with one of the keywords and a declined cover decision or with no injury with those keywords are considered declined: 'stress', 'anxiety', 'mental', 'depressive episode', 'phobi', 'depressive disorder', 'panic', 'adjustment disorder', 'dissociative', 'depression', 'dysthymia', 'depressive reaction', 'psychological', 'traumatic shock'.
- \*Please note that 'CPSP1 Clinical Psychiatrist Other Injury Assessment' particularly covers assessments for other mental injuries so the presence of a WRMI flag is used to try limit this to just WRMI though we can't guarantee that the assessment was not for a different mental injury type.
- New claims is the count of claims that were lodged within the specified period. The lodgement date may be any date after the accident occurred.
- Cost to date is total cost for a claim since it's been lodged. A claim has been lodged recent years may have less time to accrue cost so the cost to date maybe lower.
- Costs are exclusive of GST.
- Costs do not include Public Health Acute Services (PHAS) payments. These costs are for treatment in a public hospital during the acute phase of an injury and are covered by bulk payments made by ACC to the Crown. As such, these payments cannot be attributed to individual claims.
- Please note that cost isn't just for the mental injury, instead it is for all injuries on a claim where a mental injury is accepted, as we cannot split out costs by injury.
- Please note that for one claim there can be multiple injuries with description meeting criteria above, so one claim can be counted more than once in table 3.
- Ethnicity data are prioritised for reporting purposes. A client may identify with any number of ethnicities, and can select more than one when lodging a claim. For reporting purposes, ACC selects one ethnicity for each client based on the following priority order: Māori, Pacific peoples, Asian, MELAA, other ethnicities, European, Unknown.
- Age is client's age at the time of claim lodgement, which may differ to client's age at the time of accident.
- Classification unit is for the employer the claim is attributed to. Note that this is the business activity of the employer.
- In the interest of client privacy claim counts of less than four claims have been replaced with '<4' where these low numbers could result in identification of individuals. Where a total may allow suppressed counts to be derived, further suppression is displayed as '..'.
- Data were extracted 12 June 2024 and may differ if re-run later.
