Your Official Information Act request, reference: GOV-026905

Thank you for your request of 6 August 2023, asking for information about cover decisions under the Official Information Act 1982 (the Act). Our answers are provided in turn below:

1) How ACC determines cover decisions when we receive conflicting views from treating providers

When information received gives differing views or diagnoses, the cover assessor requests specialist clinical guidance, and for more complex claims, a report from an independent third-party provider.

2) Who reviews and comments on scans provided by client

Where high-tech imaging, such as CT scans, are provided by clients and it was not commissioned by ACC, cover assessors request specialist clinical review.

3) Do cover assessors have a medical background?

Cover assessors are not required to have a medical qualification. Specialist cover assessors are required to have a qualification and annual practicing certificate.

4) What medical information does ACC collect from treating providers/GPs?

When we request medical records, we only request information relating to the claim. Refer to section 3.0 and 7.0 of the 'Request medical or clinical records Policy' (attached) for more details.

As staff names were not requested, they have been deemed out of the scope of the request and removed.



Summary

Objective

To request a report from an independent third-party provider answering questions on the standard of care (if relevant), physical injury, causation, background population risk (necessary part of treatment), ordinary consequence of treatment etc.

Background

External Clinical Advice (ECA) is an opinion solely based on the paper file review from an independent provider. It helps to answer the questions on the standard of care (if relevant), physical injury, causation, background population risk (necessary part of treatment), ordinary consequence of treatment etc.

The ECA's role is to comment on clinical facts, accepted standard practice, whether a failure has occurred and likelihood of an injury occurring, taking into account the particular clients contributing factors.

ECA's do not interpret the legislation. It is the role of the Specialist Cover Assessor (SCA) and Cover Assessor (CA) to interpret the legislation against the clinical facts, and obtain further internal advice if required.

1.0 Determine external clinical advice required

Specialist Cover Assessor

a Confirm ECA is required.

NOTE When would you seek ECA?

• When you need specialised advice regarding failure, standard of care, appropriateness of the chosen treatment pathway, identification of a physical injury, causation and determining what contribution patient specific factors had in contributing to developing an injury and that advice would help you to determine cover.

• When you've had a conversation with a Review Specialist or following internal guidance and you determine external clinical advice is needed.

• You are not required to seek internal clinical advice before accessing external clinical advice.

b Identify the speciality of ECA needed.

NOTE How do you identify the specialty of ECA needed?

• Identify who was the consultant that the care was provided under.

Be mindful that this is not always the most appropriate speciality to provide comment eg client had cardiothoracic surgery and developed a bacteraemia, which then resulted in a sternal wound infection. It may be more appropriate to seek advice from an infectious diseases physician in this case.

• Look up their speciality and sub speciality to ensure that you are seeking advice from a peer with similar training and registrations.

(eg when considering cases where the treatment has been provided at a rural hospital, be mindful that a rural hospital does not have emergency physicians in their emergency department which is usually run by Rural Health General Practitioners).

• An ECA provider cannot provide comment on another practitioner's care if they do not have the same qualifications.

Example: an Obstetrician should not be providing comment on the standard of Midwifery care, we should be seeking comment from a Midwifery ECA if this is required.

NOTE Where can you access a list of ECA disciplines and specialities?

NOTE What if you are unsure of the correct ECA discipline and/or speciality to use?

• Go To 'Seek Internal Guidance' process. Use Tier 1 (self service) and Tier 2 (Hotline) guidance processes.

NOTE Can you request an ECA provider by name?

You can instruct Recovery Administration on the medical discipline and speciality required. The Recovery Administrator will then select the next available provider, with the discipline and speciality required, that has capacity to receive a referral.

You can request an ECA provider by name, if that provider has previously provided ECA advice on the same claim.

2.0 Contact client or representative and explain need for external clinical advice

Specialist Cover Assessor

- a Contact the client and confirm you are speaking with the right person by asking ACC's identity check questions.
 - ldentity Check Policy
- **b** Explain that you are referring for external clinical advice, the reason seeking advice, what information will be included in the referral, what the advice will be used for and the possible outcomes.

NOTE What else do you need to make the client aware of?

Inform the client of the timeframe you expect to receive the written advice. Sometimes the ECA may confer with other similar experienced vocationally registered health professionals for example a blind review The next steps after receipt of the written advice.

NOTE What if the client does not agree to proceed to ECA?

Find out why the client does not want to proceed to ECA and consider their reasoning and alternatives which may include making a cover decision based on the clinical information that is held on the claim. Agree with the client the next step.

c In Eos, add a contact note as a record of the conversation.

3.0 Request external clinical advice referral

Specialist Cover Assessor

a Identify all the documents that need to be sent with the referral.

NOTE What documents do I need to include?

- ACC45 Injury Claim Form
- ACC2152 Treatment Injury Claim
- All clinical notes (including radiology reports, laboratory results and other miscellaneous medical records on file)
- Treating specialist report
- Internal medical advice
- · Letters and notes provided by the client
- Death Certificate
- Coroners/Autopsy reports
- Hard copies of clinical evidence (dental moulds, cytology slides, radiological images hard copy / CD).
- b Perform privacy checks on documents.

NOTE What do you need to check?

- Check documents:
- are relevant to the referral
- do not contain any third party information
- do not contain any other information that needs to be withheld.

For details on what checks you need to complete before sending documents out, refer to NG supporting information Inbound and Outbound Document Checks and the Privacy Check Before Disclosing Information policy.

NG SUPPORTING INFORMATION Inbound and Outbound Document Checks

Privacy Check Before Disclosing Information Policy

NOTE What if you find information that needs to be redacted?

Send an email to Recovery Administration (recoveryadmin@acc.co.nz) and include the document to be redacted plus your specific redaction instructions, before adding the redacted document to the document group. You must not create and add to a document group until all redactions have been completed. Wait until you get the correct information back on the claim and then you can create your document group.

c Add the documents to the group.

NOTE What if there are documents incorrectly on other claims that need to be moved to the correct claim that has the referral-specific document group?

To move documents from one claim to the correct claim see the system steps below for Move a Document to Another Claim.

Move a Document to Another Claim

NOTE What if there are documents from other claims that are relevant to the assessment?

When a request for a referral is required and there are additional supporting documents on another claim, it is important to upload a copy of the documents to the claim that has the document group. This will ensure the right documents support the cover decisions for each claim, whilst retaining the original documents on the correct claims.

To upload documents from one claim to another:

1) Create a bulk print of all documents on the other relevant claim and complete mandatory fields and description.

- 2) Open PDF document from email link.
- 3) Upload the PDF document to the relevant claim that has the document group for the referral.
- 4) Repeat if there are relevant documents on multiple claims.

The PDF should be renamed to something short but relevant, and identify which claim number the information came from so that it is included/printed in further referrals or copy files eg 'medical records and reports from claim 100xxxxxxxx'

Do not create a bulk print on one claim and then move it to another claim, renaming it and using it in a referral for advice as it will not appear in any file copy subsequently used.

Manage document groups

- d Create a referral-specific document group with today's date and name it 'External Clinical Advice'.
- e Perform final privacy check as per step 3.0, b on any documents that have been added to document group called 'External Clinical Advice'.
 - **NOTE** What if more than one ECA is requested for the same claim? Perform privacy checks as per step 3.0, b on documents to be sent to any other ECA.

NOTE What do you need to document on Eos regarding privacy checks?

You need to write in a contact on Eos that you have undertaken privacy checks for the document group labeled 'External Clinical Advice' and the date that this was undertaken.

f From the Recovery Plan, add an activity for NGCM - Manage Referral task and choose the External Clinical Advice type.

NOTE How do you generate and send a referral task for Recovery Administration?

Go to System Steps NGCM Create a Referral Task.

What if this mesh claim?

In the e-form please that sub-specialty selected is Other, and then use the free type box to note Mesh and note preferred specialist

- Creating Manage Referral Tasks System Steps
- NOTE How do you complete the eform that is associated with the External Clinical Advice type?
 - Select specialty and sub-specialty
 - Record the basis of the claim in the 'Questions for referral' field, then leave a space
 - Enter your specific ECA questions in the 'Questions for referral' field, then leave a space
 - Specify if you need to re-refer to a specific ECA

It is not necessary to link the document group to the task. The recovery administrator will be able to locate the corresponding document group that has been correctly labelled.

Clinical questions guide

NOTE What if hard copy clinical evidence needs to be sent with the referral (ie specimens and radiological imaging)?

• You will need to send the whole ECA referral yourself via courier so that the hard copy clinical material is together with the full referral. See below note about additional information you need to include in the task in this situation.

You will then need to complete activity 7.0 when you receive a General Task from Recovery Administration notifying you that this is ready.

• If you need to send hard material, also record in the task description "Hard material - Specialist Cover Assessor will send referral"

NOTE What if additional clinical information is received after the referral has been sent to the provider?

• Create a CMO03 blank letter addressed to the ECA provider advising that we are sending additional information for them to consider as part of their report and state clearly what the additional information is: ie Medical notes from General Practitioner Dr XXX.

• Create another document group that will include a CM03 Blank letter and the additional clinical information for the ECA.

- Create a NGCM Send Letter task and link the documents for recovery administration to send on your behalf.
 You will need to complete privacy checks as per step 3.0, b and document in a contact on Eos.
- g Set the priority indicator on the task to 'high'.

4.0 Review referral task

- Recovery Administrator
- a Following the task assignment in Salesforce, navigate to Eos and select 'Do Task' from your task queue.
- b Review the task to ensure it has all the information you need to proceed .

NOTE What if you don't have all the information you need to proceed?

If required information is missing from the task, contact the task creator.

If you need guidance on working within the Administration Team, refer to the link below.

NOTE What if the referral task indicates the referral is urgent?

Contact the task creator to discuss the urgency and work together to progress the urgent referral

5.0 Identify available ECA

Recovery Administrator

a Check the Treatment Injury ECA Referral tool for the medical discipline and speciality requested and confirm the next ECA provider in line to receive a referral.

NOTE Where do I locate the Treatment Injury Referral tool?

NOTE Where can you find guidance on how to use and update the referral tool?

NOTE What if the referral task indicated the referral is urgent?

Work with the task creator to facilitate discussions with the relevant ECA provider to accept an urgent referral.

NOTE How do I know which ECA provider to use?

- Review the medical specialty and sub-specialty requested in the task.
- Search for providers which match the above requirement in the Treatment Injury ECA Referral tool:
- Provider details and filter specialty and sub-specialty (ie General Medicine, Infectious Diseases)

- Note the geographical location of the client listed in the request and select a provider from outside of the client's geographical location. If there are no providers outside of the geographical location of the client, email your Client Service Leader who will escalate to Clinical Services for resolution.

NOTE How do I confirm the provider is available and has capacity to receive a referral?

In the Provider details tab of the Treatment Injury ECA Referral tool check:

- Their availability is "Yes"
- The provider's Annual Practicing Certificate (APC) is current
- The notes section, some providers like to be called and asked prior to sending whether the basis of the claim is within their scope of practice
- Compare the maximum referrals recorded (signaling the number of referrals they can manage at any given time), with the current volume already referred or wait-listed, and waiting receipt of advice

• If the maximum number of referrals has been reached and the referral is wait listed or waiting for an appropriate ECA provider to be recruited with the specific specialty needed. Recovery Administrator to contact Specialist Cover Assessor to let them know

If in doubt, or specified by the provider, contact the provider to confirm capacity.

If the maximum referrals has not been reached and there is no wait-list, the provider has capacity to receive a referral.

NOTE What if you can't confirm the provider has capacity to receive a referral?

Select the next appropriate provider with the right specialty and sub-specialty.

NOTE What do you do if all providers with the required specialty and sub-specialty are at full capacity?

Extend the due date of the task, aligning it to when the soonest expected due date for receipt of an ECA from the identified providers. (This will keep the referral delay to a minimum).
Record a rationale in the task as to why you are extending the task due date. (This will help identify

through reporting if additional ECA providers need to be recruited and added to the list).

- Go to step b.
- **NOTE** What do you do if there are no ECA providers on the Provider details tab with the required speciality and/or subspecialty?
 - Email your Client Service Leader with the issue and they will escalate to CSAdminTeam@acc.co.nz for resolution.
 Extend the due date of the task out to three days to follow up resolution and record reasons why the task due date is extended. This information will be extracted for reporting as part of improving the ECA service.
- **b** Update the booking schedule recording the relevant details in the appropriate fields against the confirmed selected provider.

NOTE How do you correctly update the booking schedule?

Refer to 'Populating & Maintaining the Booking Schedule' within the TI ECA referral Tool Guidance info document located in the Treatment Injury ECA Referral Tool. The document provides instruction on how to and what should be recorded in the columns.

NOTE Why is it important to correctly update the booking schedule?

It is vitally important that the tool is updated and that requests that have been received are removed from the list. This allows users of the tool to accurately assess the work load of providers. This will enable visibility to your colleagues of referrals sent, when ECA is due, referrals on the waiting list and when provider has capacity so that another referral can be released.

NOTE How do you manage urgent referrals when other referrals are on the waiting list with a provider?

Contact the Specialist Cover Assessor who requested the referral and work together to enable the referral to be placed at the top of the waiting list queue.

(This should involve discussions with other Specialist Cover Assessors to agree priority based on each client situation, and to enable Specialist Cover Assessors to update clients on the status of their referral and expected timeframes).

NOTE What if this is a mesh claim?

In the task sub specialty will be noted as mesh. If a specialist s noted, find them in the ECA list. If no specialist is noted, filter by Mesh in sub - specialty (pending ECA tool update)

6.0 Create purchase order

Recovery Administrator

a In Eos, create a Purchase Order for the ECA referral by referring to the details in the e-form.

NOTE What do I add to the purchase order?

• In 'General Q+E' tab select 'Cover Assessment' under Rehabilitation Action, 'Treatment Injury-Cover' under intervention, and 'Non-Contracted' under Purchase Method.

- On Select Ent select ECA01
- · Enter 10 units for quantity approved and set frequency as 'Quarter'
- Create a purchase order
- **b** Add the vendor to the purchase order, as identified in the ECA booking schedule and Provider details, ensuring the vendor is also added as a participant on the claim.
- **c** Approve the purchase order.

NOTE What if the purchase order requires a higher delegation?

Save the purchase order and create and send a Request Authorisation Task from within the purchase order and send to a Recovery Leader for approval.

NOTE What if you get a 'Limited Payment' error message when authorising the purchase order?

Change the limited payment indicator.

1) In Eos, go to the 'Validations' tab, select 'Edit' and update the Limited Payment List Indicator to 'No'. 2) Select 'OK'.

3) Go back to the purchase order to authorise.

Once you have authorised the purchase order, remember to change the Limited Payment List Indicator to 'Yes'.

7.0 Create and send referral documents

Recovery Administrator, Specialist Cover Assessor

NOTE When would a Specialist Cover Assessor complete this activity?

Only when hard copy clinical material is to be sent.

Recovery Administrators will complete the TI40 as much as possible and save the document as incomplete. Upon receipt of the General Task from Recovery Administration, the Specialist Cover Assessors will then edit the rest of the document through to completion and send the referral documents, ensuring all steps outlined in this activity are completed.

- a Create and edit the TI40 External Clinical Opinion Request, (do not complete the document until sent to provider) Vendor letter, populating with extra information. For Recovery Administrators, the information will be noted in the ECA task. Ensure you check that all relevant information within the task has been captured.
 - **W** ADMIN TEMPLATE External clinical advice.docx

NOTE For Recovery Administrators: What do you do next if the referral task only requested a Purchase Order creation and approval due to hard copy clinical material needing to be sent by the cover specialist with the referral?

1) Ensure you have edited the TI40 as much as you can and save the document as incomplete.

2) Create a General Task and record that the purchase order has been approved and the referral is ready to be completed.

- 3) Add the purchase order number to the task description.
- 4) Transfer the General Task to the referral request creator.
- 5) Close the Medical Assessment Referral task.

Go to step 8 (the Specialist Cover Assessor will complete the rest of this activity).

- **b** Link the referral to the document group 'External Clinical Advice'.
- **c** Perform privacy checks using the Inbound and Outbound Document checks.
 - NG SUPPORTING INFORMATION Inbound and Outbound Document Checks
- **d** Check the provider's preference for receiving the referral. If the providers preference is by email and the request is not associated with hard copy material, Recovery Administrator to ensure the provider's email address has been verified.

Update the Booking schedule in the Treatment Injury Referral tool with the date the referral is sent.

NOTE What if the email address has not been verified?

Go to (NGCM) Verify Provider and Vendor email addresses process.

PROCESS Verify an Existing Provider, Vendor or Facility Email Address

e If email is the preference, create email using the requests and referrals template and attach the referral and document group. If you are unsure contact the ECA provider directly.

Emailing from Eos using a template - System Steps

NOTE What if the document is too large to email?

Break it up in chunks, if required.

NOTE What if the request is urgent?

State this clearly in the email.

NOTE What if the referral documents need to be sent via courier? Recovery Administrators - Refer to the process link below (NGCM) Prepare and Send Client Information by courier.

Specialist Cover Assessors - Refer to the Information link below Sending medical material to External Clinical Advice **PROCESS** Prepare and Send Client Information by Courier

- Sending medical material to External Clinical Advice
- f Complete a final dispatch check to ensure the Client and vendor details are correct.
- g Send the email or courier to the ECA provider. Use the email address provided under the Treatment Injury ECA Referral tool.

NOTE What if the TI ECA provider requests an update to their details or availability?

- Pass the information on to CSAdminTeam@acc.co.nz (Attn:) to have the Provider list in the TI ECA Referral tool updated.
- **h** After sending the incomplete TI40 letter to the vendor, save the document as complete this will allow the document to be edited by the vendor (to convert the document into a non-editable pdf).
- Close the assigned task and create a new "NGCM Admin Request" task, edit the task description with "ECA Follow Up" Provider Name & Due Date. Set the due date for three weeks' time and put back into the queue.

Check that you have correctly updated the Booking Schedule in the Treatment Injury ECA Referral Tool (locate the entry with your clients name and the vendor who has been previously selected under point 5.0), with the date the referral was sent to the vendor and then calculate a three week ECA report due date.

NOTE Specialist Cover Assessors sending the referral will need to update the spreadsheet with the date referral sent and ECA due date.

8.0 Follow up request for external clinical advice

Recovery Administrator

a Upon receipt of the NGCM - Admin Request task, perform a check of the documents on the claim to confirm the requested information has been received.

NOTE What if the ECA has been received?

1) Update the Booking schedule in the Treatment Injury ECA Referral tool with the ECA received date.

2) Close the "NGCM - Admin Request" task.

3) Create "NGCM - Action Attached Documentation" task and write in task "ECA received from Dr (enter name and specialty)", then allocate task to case owner/Specialist Cover Assessor.

3) Check if there is another referral on the waiting list for that provider that can now be sent to the ECA. f so,

- locate the referral task, change the due date to today's date, and record in the task description that the
 - provider can now receive the referral.

4) Change the task to high priority so that the task can be allocated and actioned same day.

Process ends.

b If the ECA has not been received, contact the ECA provider to follow up on the report.

NOTE How do you contact the ECA provider to follow up on the report?

1. You can contact the provider by email or phone call and advise the ECA provider that the report is due back to ACC. 2. Check if referral has been received by them.

3. Ask the provider what the expected timeframe for ACC to receive this report.

4. Document this clearly in the contacts of the claim with the follow heading: ECA PROVIDER CONTACTED and write within the contact the agreed timeframe to receive the report.

5. Alter the 'NGCM - Admin Request Task' to reflect the new agreed timeframe or three further weeks and place back in the queue.

NOTE What if the provider can't complete the referral?

1. Make note and close follow up task.

2. Mark as report received in booking tool and note that the provider declined the referral.

3. Call specialist cover assessor and ask them to make a new task and make mention to not refer to previous provider OR indicate al alternative provider.

4. Consider if the provider's availability needs to be changed due to reason of the declined of services.

NOTE What if the ECA provider is not responding to follow ups?

If you experience repeated difficulty communicating with the provider, eg provider is not responding to a mix of emails and phone calls after three attempts, it is reasonable to engage the Specialist Cover Assessor to determine if the referral should be cancelled and a new referral sent to another ECA provider next on the list who has capacity to receive the referral.

NOTE What if the ECA provider indicates a lengthy delay and they haven't commenced the review?

ECA Providers are very good at advising delays or that they are unable to undertake the work. Some examples of this are, taking leave, or experiencing an increased workload in their routine practice (outside of ECA) and therefore unable to provide reports. If this occurs, inform the Specialist Cover Assessor and determine if the referral should be cancelled and a new referral sent to another ECA provider next on the list who has capacity to receive the referral.

NOTE For how long should you continue following up for the ECA report?

You should continue to follow up the ECA report for as long as required until the ECA report has been received.

NGCM - Admin Request tasks for follow up of the ECA report should never be closed unless the report has been received or you have been advised by the Specialist Cover Assessor that follow up is no longer required.

- c Extend the NGCM Admin Request to reflect the earlier of the new agreed timeframe or three further weeks and place back in the queue.
- d In the Booking Schedule, add in the comments field that follow-up has occurred and the expected new date of receipt of the ECA report.

NOTE Do not change the initial six week ECA due date recorded in the Booking Schedule as changing due dates will incorrectly inform provider service level agreement monitoring occurring in another part of the business.

9.0 Review report

Specialist Cover Assessor

- a Upon receipt of the ECA report or the Alert: You Have Mail task notification from the Inbound Document Management Team that the ECA report has been attached to the claim, open and review the document.
- b Perform Privacy and Relevancy checks on the received report.
 - NG SUPPORTING INFORMATION Inbound and Outbound Document Checks

NOTE What if there are quality clinical issues or completeness concerns?

You are encouraged to deal directly with the Provider where you can, particularly if the concerns are around the completeness of the report, omissions or redactions.

However, where the quality of a report potentially falls below expectation and there may be a need to provide feedback to the ECA, these situations can be referred to a Clinical Advice Manager for consideration. The team will help you by reviewing the report and where necessary talking with the Provider.



Procedure

1.0 Complete Self-Service Guidance

b Refer to Promapp to check if next steps can be identified in using one or more of the following:

• Process pages - having knowledge of the objective, background and expected outcome of the range of services provided by ACC could help you determine the next steps to progress your client's recovery.

• Policy pages - having knowledge of legislation, payments and legal aspects of the services and supports provided by ACC could help you determine the next steps to progress your client's recovery.

• Service pages - having knowledge of the services provided by contracted Providers could help you determine the next steps to progress your client's recovery.

NOTE What if you are trying to make a cover decision?

Refer to the processes in the Make Cover Decision group in Promapp or refer to the Cover Traffic Light tool to assist in determining cover for particular injuries or injury types.

c Attempt to problem solve the issue with your Team Leader prior to seeking guidance, and that you have put together a question that is appropriate for clinical or technical guidance.

NOTE What kind of query is considered not appropriate for clinical or technical services? Ensure you are not contacting an advisor or specialist asking "What are the next steps on a claim", or "Whether or not ACC can fund something", you must attempt to provide more information relevant to the client's injury.

2.0 Determine Appropriate Type of Guidance

If you require guidance on a Surgery claim, there are two channels, ensure you use the decision tree tool to determine which one to use:

All requests for guidance on mental injury claims must go to a Psychology Advisor.

NOTE What if the Hotline is not answered?

Keep trying the Hotline. If, after a few more attempts, there is still no answer add a note to the task in Eos (or update the description in Salesforce) and try again at your earliest convenience.

If you are working in Assisted Recovery, update the description to say "Attempt to call the Hotline again", before putting the task on hold so you can pull another one from the queue. Aim to complete any on hold tasks by the end of the day, taking them off hold and returning them to the queue if you're unable to do so.

NOTE What if you need advice from a Practice Mentor about a Mental Injury (MI) claim?

Recovery Partners (MI) can book a 1x1 session with a Practice Mentor ahead of time using the link after this note.

If you need advice from a Practice Mentor right away you can call ring Recovery Support, select Option 3 and the Practice Mentor will take the claim number of the claim you need support on. This will then be passed on to the Practice Mentor with Mental Injury capability to get in contact with you.

The Decision Tree Tool references key medical information that must be on file prior to submitting a written guidance request, ensure you have attempted to request this information. Clinical and Technical staff will not be able to provide written guidance if there is insufficient information on file.

NOTE What if there are documents and/or information missing on the claim?

- **c** In Salesforce, select the 'Recovery Support' tab and 'Create Guidance'. Follow the steps and complete the fields on the written guidance form.

If there are relevant documents on file you want the advisor/specialist to review, collate them into a document group entitled 'Written Guidance document group' in Eos, and reference the name and date in the 'Documents or contacts relating to the request' section. Ensure you also note if documents from multiple claims have been added to the group.

If there are relevant contacts on file you want the advisor/specialist to review, ensure you specify the date and contact description in the 'Documents or contacts relating to the request' section.

If you need to add any particular information regarding who the guidance request should go to (i.e. If this needs to go to a specific specialist discipline), specify this information in the 'Triage Written Guidance' task description. (This is located inside the 'information' heading, ensure you save the change to the description)

NOTE What if the claim is for maternal birth injury?

Type "#MBI" in the 'information' heading of the 'Triage written guidance' task description.

NOTE What priority should I select for my Written Guidance request?

Check the Written Guidance Priority Categories document to see whether or not your request falls into one of the P1/ P2 categories. Speak with your Team Leader if you are unsure whether or not a certain scenario falls into a P1/P2 category. If your reason for escalation does not meet the P1/P2 categories, but your Team Leader agrees your request should be escalated, then please email clinicaltriage@acc.co.nz with your Team Leader approval and reason for requesting escalation.

Written Guidance requests falling into a P1/P2 category should be submitted as follows:

- Select 'P1 High' or 'P2 Medium' under 'What's the priority for this request?'
- · Select relevant drop down option under 'Why is the request urgent?'

Written Guidance requests not falling into a P1/P2 category should be submitted as P3 - Low.

High and Medium Priority Categories for Written Guidance Requests

NOTE What if you want to cancel, save as a draft, or add additional information to your guidance request?

• To cancel: Go to the guidance request you have submitted and select 'Cancel Written Guidance,' then provide a reason for cancellation (i.e. if other client information was entered in the request, select the reason as 'Cancelled due to error').

Note - the information submitted in the form is not discoverable by the client until the written guidance has been accepted and a transcript is created in Eos, if you cancel, there will be no record of it on the client's file

• Save as draft: At the bottom of the written guidance form select the tick box labelled 'Save as Draft' then click 'Next', then when you are ready to complete your guidance request, go back to the written guidance request in salesforce and select 'Edit Written Guidance'

If you are saving the request as a draft because you are awaiting some additional information:

For claims assessment staff - create a follow up task in Eos to revisit the draft guidance request once the information has been received

For Recovery team members – create a reminder action in salesforce to revisit the draft guidance request once the information has been received

• If you need to add additional information to a Written Guidance request that has been sent to Triage or allocated to an advisor – select 'Additional Information to a Guidance request' on the guidance request in salesforce

NOTE What if you are a non-Salesforce user and you require written guidance?

Ensure you request your guidance via the 'Complete Internal Referral' task and then transfer the task into the Regional Clinical Advice - CENTRAL queue or the Operations Support queue.

NOTE What if you require written guidance on a claim not migrated to Salesforce?

There is a system error which means Recovery Team Members cannot access Salesforce in order to make referrals on very old claims.

For very old claims where you are unable to access Salesforce in order to make a request for clinical advice, please action the referral using the NGCM pathway (see below systems steps) on EOS and mark the task as "OLDER EOS CLAIM, SF unavailable".

This label will ensure the Triage Team does not return the task due to being submitted in the wrong queue.

(NGCM) Create Request for Written Guidance

NOTE What if you require written guidance on a Mental injury claim or disentitlement for a Wilfully Self-inflicted (WSI)/suicide claim?

If you require guidance on the below:

• Work-related Mental Injury (WRMI) claims, and Treatment Injury Mental Injury (TIMI) claims

• Complex mental injury caused by sexual abuse (MICSA) and complex mental injury caused by physical abuse (MICPI) claims, for example, where a combination of clinical, legal and technical factors complicates the decision, for instance: multiple related claims involving technical and medico-legal complexity; where the causal link to injury is unclear or contentious; and/or the diagnosis is unusual or contentious.

• Wilfully self-inflicted (WSI)/suicide claims where the evidence to support a decision is unclear or equivocal; and/or there are clinical, legal or technical complexities that complicate the decision.

Request written guidance from a Psychology advisor, and complete the forms as outlined below. You need to fill out the relevant sections on either an ACC1517 (Mental Injury Cover form) or ACC6178 (Disentitlement for WSI or suicide claims). Ensure you leave the document as incomplete.

Complete the written guidance request form as per the current process (if you have completed an ACC6178 you can still select the tick box for 'Have one of the above ACC documents been completed') and indicate in your summary 'Refer to the ACC1517 (or ACC6178) document uploaded on XX/YY/ZZZZ'.

The PA will then arrange a Complex Mental Injury Panel (CMIP) comment via Technical Services. Once the Psychology Advisor and CMIP have completed their comments in the ACC1517/ACC6178, complete these documents and action the recommendations.

You can refer to the delegations spreadsheet below which shows what types of claims need to be referred to the Complex Mental Injury panel.

NOTE What if you require written guidance from a Technical Accounting Specialist?

Refer to the following page for more information on Technical accounting and what information needs to be included with a written guidance request.

NB: Due to the complexity of these requests there is a 3 day Service Level Agreement for urgent (client is in financial distress) tasks and a 20 day Service Level Agreement for all other requests.

PROCESS Referring to the Technical Accounting Specialists for Advice

NOTE What if you require guidance on a claim where weekly compensation has been paid for less than six months and you're considering suspending entitlements, as the covered injury has resolved? Submit written guidance to clinical only (there is no need to tick coordinated guidance). However, if due to the complexity of the client or their situation, and technical guidance is still required, then tick the box for coordinated guidance.

NOTE What if you are working on a claim that is in 'Actioned Cases'?

Written Guidance must be requested on 'active' claim, you will need to transfer this into the appropriate queue/name.

d Go to Activity 4.1 'Action Written Guidance' once you have received your guidance.

NOTE What if you have already submitted your written guidance request, and you need to update the priority?

If you have received new information that changes the priority of the request, complete the steps below: • Open the claim in Salesforce.

- · Click on the 'Recovery Support' tab and then click on the relevant Guidance Number to open it.
- Now you should be on the 'Details' page. Click on the 'Update Guidance Priority' button to change the priority of the request.
- Check the Written Guidance Priority Categories document to see which category your request meets.
- Select 'P1 High' or 'P2 Medium' under 'What's the priority for this request?'
- Select the relevant drop-down P code option under 'Why is the request urgent?'
- If your reason for escalation does not meet one of the pre-set categories, you should email clinicaltriage@acc.co.nz with your Team Leader approval and reason for requesting escalation.

FYI – If you wanted to check the progress of the task, you can click on the 'Related' tab and then click on the open task number:

- If the guidance is still with the Triage team, it will be the 'Triage Written Guidance request' task type.
- If it has already been triaged and allocated to an Advisor queue, it will be the 'Provide Written Guidance' task type.

4.0 Action Hotline Guidance

Cover Assessor, Recovery Administrator, Recovery Team Member, Specialist Cover Assessor, Treatment and Support Assessor

a Consider the advice documented by the Advisor, Specialist or Assessor and undertake the next steps.

NOTE What if you need to clarify the guidance provided by the Advisor, Specialist or Assessor? Message or call the Advisor, Specialist or Assessor directly to clarify the guidance.

NOTE What if you want an Advisor, Specialist, or Practice Mentor hotline comment to be removed from file or amended?

The only instances a clinical or technical comment should be removed/ deleted is when the guidance is on the wrong claim. In rare instances the Advisor may need to amend or add an addendum to the guidance. Only an Advisor's or Specialist's manager can delete their own comment, neither a frontline staff member or another advisor can delete your comment.

If the comment needs to be removed/amended ensure you reach out to the advisor or specialist who provided the guidance and include their manager in the discussion.

Receive Written Guidance (Recovery Team Member)

4.1 Action Written Guidance

Cover Assessor, Recovery Team Member, Specialist Cover Assessor, Treatment and Support Assessor

a In Salesforce, review the guidance provided on the Written Guidance request by selecting the 'details' tab.

NOTE What if you are requested to provide clarification on a guidance request?

If this is via IM or call, clarify the question directly with them.

If this is via Salesforce, open the Guidance Request and click 'Provide Clarification on Guidance Request', read the clarification question and provide the clarification. If you need to cancel or put the request on hold you can do this at this step.

If you need to request additional information in order to clarify the request, use the Request Clinical Records process. In Salesforce, extend the target date of the clarification task to later than the due date of the medical notes task. Ensure you update the task description to reflect you have requested additional information (if you are in Assisted Recovery and are returning this to the queue, update the description when you do this).

NOTE What if the written guidance is on a claim not migrated to Salesforce?

For very old claims where you are unable to access Salesforce in order to make a request for clinical advice, a written guidance referral would have been actioned using the NGCM pathway in EOS.

- If you decide to accept the written guidance or to ask for clarification on the written guidance provided, use the Review Written Guidance system steps below.

- If the Advisor had asked for clarification within the written guidance, use the Respond to Clarification Request from Advisor system steps below.

Receive Written Guidance (Recovery Team Member)

b Accept the guidance provided by selecting 'Accept Guidance', or request clarification if required.

NOTE What if the advice is unclear or the questions are unanswered?

Select 'Clarification Required on Guidance Provided' and input your clarification question(s).

NOTE What if you want an Advisor or Specialist's written guidance to be removed from file or amended

Comments within a Written Guidance form cannot be deleted or edited once the Advisor or Specialist has submitted their guidance.

If the wrong client's information has been included, please cancel the guidance in Salesforce and submit a new request.

NOTE What if your request for written guidance was related to transferring weekly compensation to a different claim for a further injury?

Return to 'Determine Transfer of Weekly Compensation to a new claim due to Further Injury' and continue the process.

PROCESS Determine Transfer of Weekly Compensation to a new claim due to Further Injury

c Once the guidance has been accepted a transcript will be created in Eos.

NOTE What if guidance indicates it's appropriate to suspend entitlements where weekly compensation has been paid for less than six months, as the injury has resolved?

Copy and complete the decision rationale template below and paste this into a NGCM General Task (in Eos). Assign it to a leader from your hub. Message them to let them know it's there.

Decision type SUSPEND ENTITLEMENTS DECISION

• Who was consulted [eg. Recovery Support hotline guidance from Practice Mentor received 10/03/23 and Written guidance from Clinical Advisor received 24/03/23]

• Rationale for the final decision [(e.g. Suspend all entitlements as Clinical guidance has confirmed the client's covered injury has resolved) or (Suspend all entitlements as Clinical guidance has confirmed the client's covered injury has resolved and the reason for ongoing incapacity is non-injury related)]

The leader will review and send the task back to you within 24 hours - with either their support or if they wish to discuss further.

Once your Team Leader has endorsed the decision, create a new Salesforce contact action and copy the body of the NGCM General Task into the Outcome Summary of your Salesforce contact. Close the NGCM General Task.

Follow the relevant steps in the below page for "Stop Supports".

NOTE What if guidance indicates I have sufficient information to issue a decision?

NOTE What if I'm unable to locate my Written Guidance request?

The Written Guidance process is a cog process meaning that when one action is completed it creates a new task in the process to be actioned.

For example: Once the triage process is completed, the 'Triage Written Guidance' task will be closed and a 'Provide Written Guidance Task' is automatically created which is then assigned to the appropriate advisor.

The instructional video below provides an overview of the Recovery Support Written Guidance process in Salesforce and EOS and support in locating the various tasks in this cog process.

a If applicable, provide feedback on the guidance received.

NOTE How do you provide feedback on the Hotline guidance you have received?

In Salesforce, navigate to the Recovery Support tab and select the 'Provide Feedback' option. On the Provide Feedback form, complete the mandatory guestion and comments sections, and submit your feedback.

NOTE How do you provide feedback on written guidance?

When you accept the written guidance in Salesforce, you will get the option to provide feedback, select this option, and complete the mandatory fields.

b If applicable, review feedback on the guidance request you submitted.

NOTE What if you want to review some feedback you have received?

You will be notified you have received feedback by getting an alert notification from the "bell" icon in Salesforce. If you select this you will be able to review the feedback.

Alternatively, if you select the nine dots in the top left corner of the Salesforce window, and search for "Feedback", you can select this Feedback option.

From here you can select the drop down arrow to show different list views which display feedback from a range of dates.

NOTE What if you are a Team Leader and you want to subscribe to a feedback report?



Summary

Objective

- The objectives of the process are:
- to assess the 'new injury' against cover criteria, so that the client can request supports.
- to action information about the 'new injury', so that ACC has accurate information about the client's injuries.
- to re-assess client's needs, so that the recovery pathway can be managed appropriately.

Background

Providers usually change or add a diagnosis if they made a mistake on the original claim form or have completed further diagnostics and assessments from which they identified new symptoms. The additional or changed diagnosis is referred to as the 'new diagnosis' or the 'new injury' in the context of this process, while the diagnosis provided on ACC45 is referred to as 'original diagnosis' or 'original injury'.

If the 'new injury' is different comparing to the 'original injury', we will assess cover for the 'new injury'. This is because clients might want to request entitlement(s) and support(s) to help recover from their injury, but ACC can only approve entitlements and supports for the injuries that have been granted cover.

The Accident Compensation Act 2001 allows providers (on behalf of clients) and clients to submit:

- a stand-alone request (claim) for cover
- a request (claim) for cover and treatment (or other supports) at the same time

The 'new injury' can be encountered at any stage of the recovery pathway. The following teams are responsible for assessing the 'new injury' for cover:

- · Cover Assessment teams: claims that are not actively managed, ie claims are in Actioned Cases department.
- · Assisted, Supported and Partnered Recovery: if there is actively managed claims within these teams
- Treatment & Support Assessment: when there is a request for cover and treatment at the same time.

Procedure

1.0 Receive and assess the request

Cover Assessor, Recovery Assistant, Recovery Coordinator, Recovery Partner, Treatment and Support Assessor

- a Review the information for an additional injury or change in diagnosis. This can be via any of the following documents:
 - an ACC18 Medical Certificate.
 - an ACC554 Medical Certificate with permanent impairment.
 - an ACC125 additional information on diagnosis.
 - A request from the client's treating provider (eg letter from provider, Surgical ARTP).
 - an ACC2152 Treatment Injury Claim.
 - ACC32 Treatment Extension Request.
 - NOTE What if you receive a request via MyACC task NGCM Request Change in Claim Information? Contact the client and advise that they need their treating provider to formally lodge a request.

NOTE What if you are unsure if you have a request for additional cover?

If the request is within the timeframes for assessing cover, clarify with the lodging provider if there is a request for an additional injury or change in diagnosis.

If the request is not within the timeframes for assessing cover, refer to Technical Services for guidance following the Seek Internal Guidance process.

NOTE What if new medical information is received and excluded from above list?

We consider all new medical information received on a claim. ie Clinical notes, Specialist reports, MRII's/Xrays). This information does not always constitute an additional injury or change in diagnosis cover request unless there is an explicit request from the treating provider.

If that information would change the current diagnosis (but is not explicitly requested) then we may seek a change or request via their treating provider who would complete an ACC18 or ACC32 and submit to ACC for consideration.

NOTE What do you need to consider when the entitlement request is received and deemed cover exists? Refer to the Deemed Cover and Entitlements Policy for considerations to determine client entitlement eligibility while in deemed cover period.

Deemed Cover and Entitlements Policy

NOTE What if the client, provider, or advocate has called and advised ACC verbally of the request? Inform the party that the request needs to be in writing, advise them to go to the ACC website for more information.

- b Check you have all of the minimum required information on the request:
 - the injury diagnosis (code and description).
 - the body site of the injury (if applicable).
 - the date of accident or event (in which the person was injured).
 - short description of why adding or changing a diagnosis.

NOTE What if information is missing?

Contact the provider to clarify if this is a request for an additional diagnosis or change in diagnosis and obtain the missing information.

c Confirm the client has an accepted claim.

NOTE What if the request is for a new event?

A new claim must be lodged.

I've attached a copy of the ACC45 form for this claim, in which the client authorises ACC to collect information to determine what support ACC can provide.

This request is in line with Principle 2(2)(c) and disclosure is in line with Principle 11(1)(c) of the Privacy Act 2020."

Cover criteria for pre-existing conditions Policy vite



Summary

Objective

If a client has a pre-existing condition and suffers a personal injury, the personal injury may be covered but the pre-existing condition will not. However, if the pre-existing condition has previously been accepted for cover, the worsened condition may be covered under the existing claim.

The AC Act 2001, Section 26(4) states that personal injury does not include personal injury caused wholly or substantially by the ageing process.

1.0 Taking a person as they are

a If a person with a pre-existing condition has an accident, they may sustain more serious results from the accident than a healthy person. They have a right to compensation for the more serious results. See Examples of pre-existing conditions.

You may sometimes hear this referred to as the "eggshell skull principle" or the "thin skull rule". It means that we consider all claims for cover on their own merits, without giving weight to any pre-existing conditions.

2.0 Aggravation or acceleration of pre-existing damage

a We will not cover the aggravation or acceleration of pre-existing damage that is a natural step in the process of deterioration, without evidence of a fresh injury.

3.0 Obtaining medical information

- a When obtaining medical information you must:
 - establish the cause of injury, to determine whether the injury is the result of an accident
 - get a description of any significant pre-existing condition.

You should collect the following information to get a full picture of a client's condition:

- full diagnosis of the condition claimed for
- likely prognosis of the condition
- description of any significant pre-existing medical condition that may have caused or contributed to the injuries claimed for

• details of any other medical practitioner consulted about either the injuries or a pre-existing medical condition that may be related to the injuries claimed for

- copies of any medical reports, x-rays or clinical test results that may be related to the injuries claimed for
- information about any unusual features of the injuries.

If you contact medical practitioners by phone, make sure you get a written response from them as well.

4.0 Adjacent Segment Disease

- a Adjacent Segment Disease (ASD) is a term describing pathology that has become symptomatic following a spinal fusion. When a person has one or more levels of their spine fused surgically to treat disc pathology caused by a covered back injury, the adjacent disc level above or below the fused segment may be subject to extra load and stress because those levels are now the lowest remaining mobile segments.
- **b** Only spinal fusion surgery has the potential to cause adjacent segment disease. The way in which disc prolapses contribute to ASD is not scientifically well established.

Cover for ASD is not available if a fusion accelerates the progression of pre-existing degeneration at an adjacent level.

ASD arising from non-ACC funded fusions would not be covered unless the disease met the criteria for a treatment injury.

The fact that ACC has funded an earlier fusion which, in turn, is alleged to have caused ASD is not enough in itself to determine causation.

5.0 Examples of pre-existing conditions

a Example 1

Paul is being treated for cancer. While undergoing a course of radiotherapy, he falls and fractures his knee. His claim will be accepted for cover for the knee fracture, but not for the pre-existing cancer.

Paul's entitlements are limited to the separate consequences of the knee fracture. For instance, ACC may contribute towards the cost of treatment of the fracture by an orthopaedic surgeon, but not towards any cost of further radiotherapy.

b Example 2

Ann is aged 85 years and lives in a rest home. She falls and fractures the neck of her femur.

The fracture heals but Ann does not become as mobile again. A year later, when the fracture is healed, she contracts pneumonia and dies. Because there is no direct causal link between the fracture and Ann's death, ACC is not responsible for any costs arising from the pneumonia and death.

c Example 3

Carl is aged 85 years and lives in a rest home. He falls and fractures the neck of his femur.

Because of the fracture, Carl is immobilised in bed and cannot even sit up. Within a few weeks, he has congestion in his lungs because of his immobility. Carl contracts pneumonia and dies.

The claim for cover will be accepted for Carl's death, because there is a clear chain of causation. The fall caused the fracture, which caused the immobilisation, causing the congestion in the lungs. The congestion led to pneumonia, which caused Carl's death.

d Example 4

Scott, aged 52, has an osteoarthritic hip joint. He is still reasonably mobile, but it is anticipated that, at some time, he will need a replacement joint.

While swinging his golf club one day, Scott twists his hip joint. His claim will be accepted for cover for the twisting, but not for the underlying osteoarthritis.

e Example 5

Cath has suffered from the effects of Scheuermann's disease (an osteochondritis of the spine) since her teenage years. This will gradually deteriorate so she will not be able to flex part of her spine.

When lifting a bolt of material, Cath severely strains her back muscles. Her claim for the muscle strain will be accepted for cover, and she can receive appropriate entitlements while the strain heals. But as soon as the deteriorating osteochondritis becomes the substantial cause of Cath's back problems she will lose her entitlements.

f Example 6

Brent is an active diabetic who slips while cutting firewood and a splinter pierces his foot. The injury, because of his preexisting poor circulation, leads to gangrene in a part of the foot. This has to be excised in two separate operations.

Brent's claim will be accepted for cover for the splinter incident and his entitlements extend to the two separate operations. However, ACC has no responsibility for other measures that are required, for example a vein transposition, which is a prophylactic measure undertaken to improve the blood circulation to what remains of Brent's foot.

g Example 7

Brenda has always been inclined to minor depression, but did not need any treatment other than rest. She sustains serious chest injuries and other abrasions in a motor vehicle accident. As a result of these physical injuries Brenda suffers a post-traumatic stress disorder (PTSD).

The PTSD needs medical treatment, which prevents Brenda from working for a time. ACC will accept the claim for cover for the PTSD and for her physical injuries.

Summary

Objective

Client medical or clinical records help in a range of situations. They:

- help inform cover and support decisions
- · provide further information about the injury, client and diagnosis
- · help develop the rehabilitation plan
- · help identify and manage any risks.

We can ask providers, including general practitioners (GPs) and District Health Boards (DHBs) to provide us with these medical or clinical records. See Requesting clinical records from DHBs. Providers who spend time preparing medical or clinical records (including completing an ACC554 LSIA medical certificate), can invoice ACC for that time.

Policy

1.0 Rules

a When dealing with a client's medical or clinical records, we must take care to observe the requirements of the Privacy Act 2020 and the Health Information Privacy Code 2020. For more information, and the difference between personal and health information see ACC's privacy page.

A client must supply us with the information we need to make a decision about a claim unless they have a reasonable reason not to. See the Accident Compensation (AC) Act 2001, Section 72. Section 55 of the Act refers to the 'Responsibilities of the claimant to assist in establishment of cover and entitlements' and generally extends to responsibilities at the request of the Corporation. This means that ACC will, as part of its investigative role, request the relevant supporting information from the client, and their treating providers. Once investigations are complete, a decision can be made on the claim.

All medical or clinical records provided to ACC must be kept on the client's file.

2.0 When to request medical or clinical records

a When the client requests cover, additional diagnosis, support, or treatment from ACC, the onus/responsibility rests with the client and/or their provider to supply supporting clinical or medical information to help us to make the decision. If the client and/ or their provider has not supplied the supporting information, ACC will, as part of its investigative role, request the relevant supporting information from the client, and their treating providers. Once investigations are complete, a decision can be made on the claim.

On the other hand, if ACC is considering withdrawing support or treatment, revoking cover, or ceasing entitlements such as weekly compensation, then the onus/responsibility sits with ACC to request the supporting medical or clinical records

Before making a request, you must ensure that the information has not already been requested. You must also check that clients are registered patients at the medical practices where notes need to be requested from.

When a provider requests additional treatment or other support on behalf of their client they should include all medical or clinical records with their request, at no additional charge to ACC or the client.

- b Overseas medical records may be required in ordered to determine cover on a claim. In these cases, it is ACC's position that ACC is responsible for the sourcing of the medical records from the overseas provider as well as paying the provider directly for those records. This responsibility doesn't extend to ACC sourcing and purchasing overseas medical records for the purpose of investigating entitlement and/or treatment.
- c Sections 56 and 57 Accident Compensation Act 2001 (the act) state that ACC must investigate cover on a claim at its own expense. There is nothing in the act barring ACC from gathering medical records from overseas when the records are required to determine cover.
- **d** Examples of when overseas medical records may be required to determine cover:

• A client who meets the definition of being ordinarily resident in New Zealand who suffers a personal injury whilst overseas and seeks cover for that injury when they return to New Zealand.

• A medical specialist comment is required from an overseas-based specialist due to the level of expertise required (e.g. complex treatment injury claims where an opinion is sought from an overseas based medical specialist who is an expert in the relevant field).

• A client has immigrated to New Zealand and it needs to be determined whether their personal injury sustained in New Zealand is a new injury or a reaggravation of an injury that occurred overseas before the client emigrated.

3.0 Limits on what we can request

a You must have a reason for requesting medical or clinical records.

We're only allowed to request information relating to the claim, so the provider must review the record and edit out any unrelated information. You must therefore use the correct service code to allow them to do this if necessary and invoice us correctly.

4.0 Medical or clinical record request forms and letters

- a You must use the correct form or letter to request medical or clinical records.
- **b** To request clinical notes and medical reports from providers use the relevant form or letter:
 - MD09a Further info consultation notes vendor
 - MD09b Allied Further info Consultation Notes Vendor
 - **NOTE** Please make sure you have specified where the provider/vendor should send the requested notes to (the correct return email or postal address).
- c Work Injury Inquiry Team

MD10b Allied - Further info - Medical Questionnaire - Vendor

5.0 Non-DHB provider medical or clinical records - Prior approval

a If medical or clinical records are likely to take more than an hour to prepare, the provider must get prior approval from the case manager who raised the initial request.

6.0 Service codes and prices

- a See Codes and prices for non-DHB medical or clinical records.
 - Codes and prices for non-DHB clinical records

7.0 Types of medical or clinical records

- a The type of medical or clinical record(s) required will depend on the reason for the request. Records can include:
 - · copies of specialist reports, directed from one medical practitioner to another
 - investigation results
 - clinical notes
 - reports by medical consultants
 - · hospital records, including admission and discharge summaries
 - · counselling notes for sensitive claims
 - notes on surgical operations
 - · pathology and laboratory tests
 - reports on special tests and diagnostic procedures including x-ray and scan results
 - physiotherapy notes.

8.0 Quality

- a The number of medical or clinical record pages received from a provider may not reflect the time spent reviewing and editing. If you have concerns about the quality or quantity of provider medical or clinical records or their invoices, discuss this with:
 - a medical advisor
 - your supplier manager
 - the provider.

9.0 District Health Board (DHB) medical or clinical records - Knowing your DHB

a Knowing how the DHB you work with stores and processes their client medical or clinical records will help you with your requests. For example if a client is still in hospital, their medical record will be on their hospital ward, rather than with the hospital medical records department.

Avoid making duplicate requests. You must make sure the request is necessary and complete the forms thoroughly.

Request the medical or clinical records from the correct contact.

10.0 Level of urgency

11.0 Prior approval

- a If you're requesting more than 340 pages from the DHB, they will seek prior approval from the case owner. The case owner must then consider whether the volume of information is actually needed. If it is needed, either:
 - amend the request to be more specific, ie request a date range or a particular treatment event, or

• give approval to proceed as originally requested, and adjust the purchase approval increasing the price accordingly.

12.0 Service codes and prices

a • the payment rates that DHBs charge ACC for copies of medical or clinical records are standardised across the country
 • the DHBs know to claim payment for a range rather than a number of pages, eg 1-20 pages etc.

13.0 What we don't pay for

- a Missing mandatory information including:
 - documentation required as part of the Non Acute Rehabilitation Services Schedule (ACC74, ACC739, ACC9 and ACC740)
 - documentation that may be attached to support the ACC705 which could include Emergency Department/Discharge report, ACC45, Allied Health Needs Assessment
 - services provided in a fracture clinic under the Clinical Services contract.
 - A purchase order should not be loaded for a payment for these requests.

14.0 Types of medical or clinical records

a The type of medical or clinical record requested will differ depending on the reason for the request.

Type of record requested on ACC2386 (Clinical Records Request – DHB)	Example
Operation notes	Note on surgical operations
Clinical letters or notes	The medical or clinical records that describe all assessment and treatment by the team or specialist that have managed the client's injury either while an inpatient and/or outpatient – should be requested using the DHBC code. If you need a specialist's opini on a specific question use the DHBR1 code and an MD02c letter
Radiology reports	X-ray, MRI, CT scan reports. Do not request hard copies of x-rays and MRIs. Radiolog reports may be included in an Assessment Report Treatment Plan (ARTP)
Discharge summary	Summary of treatment received and ongoing plan when the client is discharged from hospital
Other, eg physiotherapist, OT	Reports/records/assessments from the physiotherapist, occupational therapist, speech therapist, social worker, who saw the client while they were in hospital. If you require an answer to a specific question, request this using the DHBR2 code and MD02c letter

15.0 Exceptions

- a The Elective Surgery, Treatment Injury and National Serious Injury Service units may have specific requirements when:
 - making a request for a medical or clinical record
 - determining cover or support
 - managing the rehabilitation or risks
 - What is requested is generally directed and reviewed by a Clinical Panel
 - Treatment injury or elective surgery may request the client's full DHB record including nursing notes.

b When requiring mental health records, there are specific timeframes and requirements:

To ensure ACC only collects information relevant and necessary for decision making, we need to communicate with our clients to determine a timeline for which to collect mental health records.

This aids in establishing a timeline with the client of their engagement with mental health services, organizations and Primary Health Care services.

16.0 Quality

a The number of pages received from a DHB may not reflect the time spent reviewing and editing. If you have concerns about the quality or quantity of medical or clinical records or their invoices, discuss this with your team manager.

17.0 Completing the ACC2386 Clinical Records Request – DHB

a All components for Section 1 (vendor details), Section 2 and 4 (patient details) and Section 6 (ACC staff member details) must be completed.

Section 3 (request details) is the most important section to complete accurately and may take the longest.

- Injury review the claim Injury and Medical tab in Eos to assist you in identifying or confirming the injury
- Dates you require the records you may have many options for confirming the dates the client was in hospital for example, ACC74, ACC9, ACC705 or check with the client directly.
