Thank you for your email of 3 May 2023, asking for the following information under the Official Information Act 1982 (the Act):

are looking to understand what the market size is for all Hand Rehab related injuries to aid in future planning. To understand this, can I please request for the following:

- ACC national spend on Hand Rehab injuries (either through Hand Rehab contract, EPN contract or regulations funding). This would include any rehabilitation spend for injuries related to the elbow, forearm, wrist and hand.
- Can we please have this data by month from 1st April 19 to the end of April 23
- Can we please also have this at a national level, broken down by client residential region?
- Could we also have the spend by month from 1st April 19 until the end of April 23, broken down by client residential region but only for hand rehab related injuries which came under the Hand rehab contract?
