# Your Official Information Act request, reference: GOV-026678

Thank you for your email of 27 July 2023, asking for statistics on the incidence of complex regional pain syndrome (CRPS). Due to the nature of your request, we are responding under the Official Information Act 1982.

Please find below the number of new claims for CRPS lodged between 1 January 2018 and 31 July 2023. The data has been broken down by cover decision and calendar year. The injury descriptions used to identify CRPS are attached as an appendix to this response.

#### Notes about this data

- A claim may have multiple injuries and an accepted claim may have a mix of accepted and declined
  injuries. In this dataset, the claim will be counted as accepted only where the CRPS injury is accepted
  for cover.
- Where the cover decision is 'held' the claim is accepted for cover, but the CRPS injury is still being investigated.
- An injury can be added to claim when it is lodged with ACC or at a later date.
- The data excludes claims managed by an accredited employer as ACC holds little data about these claims.
- Data was extracted 1 August 2023 and may differ if extracted again at a later date.
