Your Official Information Act request, reference: GOV-016834

Thank you for your email of 17 February 2022, asking for the following information under the Official Information Act 1982 (the Act):

I am seeking data on the number of treatment injury claims ACC has received, processed, granted or declined over the past decade.

I see from ACC material that roughly a third are declined annually [sic].

I therefore seek information for data collected in the financial years from 2011-12 through to 2020-21 (presuming this is the latest information available).

*In those 10 years, how many claims for treatment injuries were lodged with ACC ? [sic]

On 3 March 2022, we emailed you to provide an update regarding the progress of your request and noted that to extract the number of appeals lodged in relation to declined Treatment Injury claims would likely take a significant period of time. You replied, advising the following:

please provide district court decision data, and then appeals data, which is central to the story we are planning.

A treatment injury is a personal injury caused as a result of seeking or receiving medical treatment from, or at the direction of, a registered health professional

In order to fulfil the criteria for cover, the person must have suffered a personal injury and there must be a clear causal link between the treatment and the injury, and the injury must not be a necessary part or ordinary consequence of the treatment.

When considering treatment injury data, it is important to note that the number of claims lodged with ACC cannot be taken as an accurate indication of the occurrence of injury during treatment or the quality of care. This is because, among other reasons, not all occurrences of injury during treatment are lodged with ACC.

We are unable to provide the number of appeals lodged for declined treatment injury claims

To determine the issue being appealed (in this case, a declined treatment injury claim) would require us to manually read through all appeals lodged with ACC over the last 10 years, requiring substantial collation or research. As such, we are unable to provide you the number of appeals lodged for declined treatment injury claims specifically. This decision has been made under section 18(f) of the Act.

In doing so, we have considered extending our timeframe to respond to your request and charging (under the Act). However, it has been determined that the resources required to extract the information would have a significant impact on the everyday functions on the team involved.



We can provide you a count of declined treatment injury claims, by District Court decision and calendar year.

The data was extracted on 24 February 2022.
