

The challenge

Costs of providing entitlements have grown significantly in the past decade. This indicates worse recovery rates for clients and more pressure on the Scheme.



Problem Statement: We're seeing more people requiring time off work due to injury, and their average time to recover and return to work and independence, is getting longer.

"...issues that, if left unaddressed, are likely to result in the next generation having to pay significantly higher levies and taxes to ensure the Scheme remains sustainable."

Improving return to work outcomes

Request for Proposals (RFP) – now live on GETS

- The purpose of this RFP is to contract directly with organisations with strong links to general practice clinics and that have influence among clinicians to drive better return to work and rehabilitation outcomes for our kiritaki.
- As certifying practitioners, you are uniquely placed to assess and determine a patient's suitability for recovery at work.
- We're aiming to ensure that certification more accurately reflects the individual's injury and recovery potential – to help our kiritaki get back to the things they enjoy sooner.



Updating ACC45/ACC18 forms

Addressing known pain points

Current State

Significant variation in clinical pathway and client experience

Time consuming, difficult to navigate, lack of flexibility

60-70% subsequent med certs for non-serious injuries signed off as FUF

Fragmented communication

Transactional

Future State

Best practice certification and rehabilitation

Efficient, intuitive and integrated forms

Medical certification that promotes active recovery, and early and safe return to work and independence

Enhanced communication and collaboration

Certification seen as a key moment in time in a client's recovery journey



General practice dashboard

For certifying practitioners

- Allow certifying practitioners to see certification and return to work data for their patients
- Ability to segment by specific cohorts, such as injury type, work type, age groups and ethnicities
- Provides comparison over time and with peers at a practice, PHO and national level
- Data will be also be shared with practices and PHOs



ACC changes

- Reinstatement of one-to-one case management for clients with injuries that are impacting on their ability to work
- Additional training for ACC frontline staff
- Return to work resources developed for clients, providers and employers
- BPAC education module and podcast launched
- Updates to **Vocational Rehabilitation** contract
- Recovery at work trials with over 100 employers across New Zealand, representing diverse industries and geographic locations.
